A. Parks and Recreation Director Recruitment

Director Brandt announced her resignation and informed the Commission that the recruitment to fill the Parks and Recreation Director position is open. The scheduled close date is September 6, 2022.

6. **REPORTS**

A. Staff

Director Brandt provided a summary of summer activities, programs, and events. Moraga Day Camp saw record enrollment this year, and nearly all of the scheduled contract camps ran as scheduled.

B. Liaison/Committee Reports

Schools (Crain) - None

<u>Art in Public Spaces Committee</u> (Pelchat) – Commissioner Pelchat announced that the APSC held a quarterly meeting earlier that evening and that there were two sculptures being recommended to the Park and Recreation Commission for consideration at West Commons Park.

<u>Volunteer Report (Kolm)</u> – Director Brandt announced that Planning Commissioner Karl Davis has led and organized a volunteer fire abatement effort on August 13. Other Reports - None

7. **NEW BUSINESS**

A. 2022 Activity Guide

Director Brandt announced the release of the Fall / Winter 2022-23 Activity Guide. The format was adjusted to make the Fall / Winter months combined into one guide, when the Winter months were previously combined with the Spring. The updated design reflects a more modern design format. Director Brandt reviewed the Activity Guide page by page to highlight the new and popular classes and events. Town ASEP is featured for the entire 2022-23 school year as requested by families for advance childcare planning. Town ASEP is scheduled to begin on September 6, 2022.

B. Park Project Update

Director Brandt provided an update on the completed, in-progress, and scheduled projects at each of the Town parks. Projects include those approved by Town Council as part of the 2022/23 Operating and Capital Improvement Project budgets which is inclusive of capital projects, asset replacement, and minor operating projects.

C. Consider Relocation of "Helical Wind Spinners" to West Commons Park
As recommended by the Art in Public Spaces Committee, the original "Wind Spinners" by
artist Buddy Brodwin were substituted by a larger, aluminum version that would be more
conducive to the location of West Commons Park. In addition to the "Wind Spinners" the
Art in Public Spaces Committee also requested the Park and Recreation Commission
consider "LOL" by artist Buddy Brodwin for the same location. "The Pear" that was
previously approved is delayed. The Art in Public Spaces Committee desires to have a
cluster of three sculptures at West Commons Park so that the placement is intentional.
