

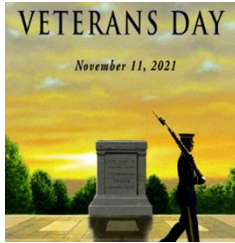

VETERANS DAY - THURSDAY, NOVEMBER 11

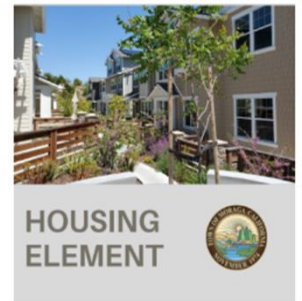

The Town of Moraga falls within the Association of Bay Area Governments (ABAG) region. The State has determined that the Bay Area region must plan for an additional 441,176 new units, of which Moraga's allocation is 1,118 new housing units. Community input is an essential component of developing a strategy for the 2023-2031 Housing Element. Please join us!



STORM PREPAREDNESS AND SANDBAGS



Self-service sandbags are available at no charge to Moraga residents at the Rancho Laguna Park parking lot (2101 Camino Pablo). Please take only what you need and fill bags one-third full for stacking. Moragans are encouraged to plan ahead for winter storms. Here are a few tips:

- Inspect drainage inlets, gutters, ditches, pipes, and creeks on your property and remove any debris that may be blocking the flow of water.
 - Visit the [FEMA Flood Mapping Center](#) to look at flood maps of your area.
 - Learn about the Contra Costa County Flood Control's [7-5-3-2 Flood](#) forecasting tool to warn of potential flooding periods.
- Plan for food, water, medical and personal comfort needs for each household resident and plan an evacuation route in case of fast-rising water. Visit [Ready.gov](#) for more information.

RECENT TOWN COUNCIL ACTIONS ON OCTOBER 27, 2021

COUNCIL APPOINTS SONA MAKKER TO TOWN COUNCIL

Town Council continued their discussion regarding appointment of an individual to fill the Town Council seat vacated by David Stromberg until the November 2022 election and ultimately voted 4-0 to appoint Sona Makker to the Town Council. Sona will be sworn in at the November 10, 2021 meeting. Welcome Sona!

HOUSING LEGISLATIVE UPDATE REPORT

Town Council received a report on California Housing Legislative Updates to reform housing throughout the State presented by Eric Phillips, J.D. with Burke, Williams & Sorensen LLP. The drivers include the [Regional Housing Needs Allocation \(RHNA\) and methodology](#), the [Final Plan Bay Area 2050](#) and key legislation from the state. In general, the next housing element is vastly different from prior cycles due to recently enacted pro-housing and affordable housing regulations and increased accountability for non-compliance. PROCLAMATION DECLARING UNITED AGAINST HATE WEEK

Town Council declared November 14 to 20, 2021 United Against Hate Week in Moraga. The Town committed to showing support for all members of our community and standing together in opposition to bias, bigotry, and intolerant treatment. The Town further encourages residents and community organizations to work together in opposition to hate. AWARD DESIGN CONTRACT FOR 2022-23 PAVEMENT RECONSTRUCTION PROJECT

The Council authorized an engineering design agreement for the 2022-23 Pavement Reconstruction Project to Harris and Associates of Concord, CA. Harris is focusing on designing two construction bid packages for the Town's worst streets which are under 50 PCI (on the 1 – 100 Pavement Condition Index scale). Phase 1 construction is scheduled to occur in 2022 and Phase 2 is scheduled for 2023. Additional information will become available on the Town's website as the project progresses.

MORAGA WAY AND INTERSECTION IMPROVEMENTS PROJECTS

The Town Council accepted the Moraga Way and Canyon Road/Camino Pablo Improvements project as completed by Ghilotti Construction Company which included a Change Order for the crosswalk and traffic safety work for the Moraga Road and Alta Mesa Intersection project. The final construction cost was \$3,559,142 funded by Measure K, SB-1 Gas Tax, Street Light Special District, Garbage Vehicle Impact Fees and grant funds from CalRecycle, CCTA, and MTC organizations.

USE OF MEASURE K FUNDS

Given the importance of the subject matter, Town Council directed staff to bring this item back at a future meeting when the full five-member Council was seated.

TOWN COMMISSION AND COMMITTEE APPOINTMENT PROCESS

Town Council agreed with staff that it made sense to streamline the annual process for filling openings on all of its Commissions and Committees. In the future, Council will only interview new applicants and applicants who are re-applying to a Commission or Committee in which there is more than one person applying for the seat.



PRIVATE STORMWATER DRAINS RESPONSIBILITY

As with most other public agencies in Contra Costa, it is the property owners' responsibility in Moraga to maintain and clean above and below ground drainage on your properties and, in many cases, along the frontage of your property. Unmaintained storm drain pipes, driveway culverts, ditches, swales, and creeks can clog, causing localized flooding and damage.
