CANYON ROAD BRIDGE IS NOW OPEN TO TWO-WAY TRAFFIC

This week marks a significant milestone, as both lanes of the Canyon Road Bridge are now open! The new Canyon Road Bridge is the largest public works project in the Town's history. The bridge is a modern superstructure, a cast-in-place, post-tensioned concrete box girder to be exact, that will stand strong for 75+ years serving generations to come. The magnificent project has been in the works since 2013 and includes the coordination of two bridge designs (an original design, and a redesign) as well as the installation and removal of a temporary bridge.

The new Canyon Road Bridge boasts 380,000 pounds of steel rebar and 5 million pounds of concrete. The bridge is supported by 2,000 feet of underground piling support structures. The new bridge incorporates two lanes for vehicle traffic, and also includes wide bike lanes, and a 10' multi-use pathway that connects to the regional trail network. The \$12.7m project has come in under budget and includes funding from Caltrans (\$11.3m) and Contra Costa Transportation Authority (CCTA) Measure J funds (\$1.4m) to fully-fund the new Canyon Road Bridge.

Town Councils past and present have prioritized this project and Town staff have worked tirelessly to ensure minimum disruption and inconvenience to our residents. Thank you to the many partners who made this vision a reality – Contra Costa County, Caltrans, CCTA, East Bay MUD, East Bay Regional Park District, and the numerous contractors and consultants working on this project. We appreciate the support and patience of the Moraga residents, and the community of Canyon who have been impacted by this project for many years.

The remaining work on the bridge is mostly cosmetic. Over the coming months contractors will work to finish decorative railings, install lighting, and complete landscaping and site restoration.



BOLLINGER CANYON COMMUNITY MEETING - JANUARY 25

On Tuesday, January 25, 2022 from 6:30 to 8:00 pm the Town will host a Bollinger Valley Community Meeting via Zoom to obtain early input and feedback from residents on re-zoning options for the Bollinger Valley area which is currently

designated a “Study Area”. Zoning determines, among other things, what type and amount of development can be allowed on a parcel. This project is a Town Council goal and a part of the Comprehensive Advanced Planning Initiative to update the Housing Element, complete an Environmental Impact Report, and Rezone including the Bollinger Valley Special Study Area. MOFD AWARDED \$6.3 MILLION FIRE PREVENTION GRANT

The Moraga-Orinda Fire District has been awarded a \$6.3 Million CAL FIRE Prevention Grant for the Tunnel-East Bay Hills Fuel Break Project. The project will remove hazardous fuels in an area covering more than 20,000 residents and 2,775 acres, running from western Orinda through Oakland, Berkeley, Moraga and into the unincorporated communities of Canyon and Bollinger Canyon. FREE AT-HOME COVID-19 TESTS NOW AVAILABLE

To ensure that all Americans have access to timely COVID-19 testing, the U.S. Department of Health & Human Services has announced a national program that enables every home in the U.S. to order four free at-home COVID-19 tests. Tests are free and arrive to your home through the mail by the U.S. Postal Service. The rapid antigen (not PCR) at-home tests can be taken anywhere and results are available within 30 minutes.
