### Contra Costa Mosquito and Vector Control District Board of Trustees

The Contra Costa Mosquito and Vector Control District was formed in 1927 and is dedicated to the health and welfare of the county's more than 1 million residents covering 736 square miles. Funded through tax dollars, the District offers free services for mosquitoes, rats and mice, ground-nesting yellowjackets, ticks, and skunks. The Contra Costa Mosquito and Vector Control District Board of Trustees are officials appointed by their respective City Councils to govern the Mosquito and Vector Control District knowledgeably and effectively.

**Qualifications:** Must be a Moraga resident and 18 years or older with an interest in any of the areas of: public health; public policy; wetlands; farming; community education; or land development.

**Duties:** Attend meetings as the appointed member.

**Meetings:** Held on the **second Monday of every other month** at the District office, 155 Mason Circle, Concord at 7:00 p.m. **(Meetings will be held virtually via Zoom until further notice.)**

**Term of Office:** First term is two years. Additional terms are two or four years.

**In Lieu of Expenses:** \$100.00 per month is paid to each Trustee, only if they attend a meeting, regardless of the number of meetings attended.
